#### 1. Introduction

As part of the implementation of the *First Nations Land Management Act* for the Lower Nicola First Nation Reserves, the Surveyor General Branch has prepared a Land Description describing the extent of the Reserve lands as required under Section 6.1(a) of the Act for Hamilton Creek Indian Reserve No. 7.

Outstanding issues related to the jurisdictional boundaries of the Reserve or to the Land Description contained in this Report are explained in Section 4.

The Land Description contained in Section 2 deals with the extent of the Reserve lands that will be subject to the Land Code of the Lower Nicola First Nation under the *First Nations Land Management Act* and is not intended to prejudice any of this First Nation's claims to lands.

The Land Description is based on a review of the Indian Lands Registry and other documents pertaining to the extent of title to the Reserve. The Land Description is not a legal interpretation of those documents. As there may be different legal interpretations of the documents, legal assistance may be required to determine the nature of the legal interests. The content of this Land Description is accurate based on the documents reviewed; however, there may be other documents that were not found or uncovered that may affect the extent of the title to the Reserve.

This Land Description Report was prepared by Cade H. Brown, BCLS, CLS, of the Surveyor General Branch, per the Guidelines established under the authority of the Surveyor General of Canada.

#### Hamilton Creek Indian Reserve No. 7

Land Description of the Extent of Reserve Lands that will be subject to the Land Code of the Lower Nicola First Nation under the First Nations Land Management Act.

Reserve Lands within the Province of British Columbia, Canada In Kamloops Division of Yale District, more particularly described as:

All of Hamilton Creek Indian Reserve No. 7 bounded on the east by the boundaries of said Reserve shown on Plan 4642 recorded in the Canada Lands Surveys Records (CLSR); and bounded on the south by the boundaries of said Reserve shown on Plan BC1023; and bounded on the west and north by the boundaries of said Reserve shown on Plan BC 208 CLSR.

Save and except all that portion of land more particularly described as road parcel shown on Plan 104843 CLSR.

Total Lands containing 1780 hectares, (4398 acres) more or less.

#### The above described Reserve Lands are subject to:






