### 1. Introduction

As part of the implementation of the *First Nations Land Management Act* for the Lower Nicola First Nation Reserves, the Surveyor General Branch has prepared a Land Description describing the extent of the Reserve lands as required under Section 6.1(a) of the Act for Speous Indian Reserve No. 8.

Outstanding issues related to the jurisdictional boundaries of the Reserve or to the Land Description contained in this Report are explained in Section 4.

The Land Description contained in Section 2 deals with the extent of the Reserve lands that will be subject to the Land Code of the Lower Nicola First Nation under the *First Nations Land Management Act* and is not intended to prejudice any of this First Nation's claims to lands.

The Land Description is based on a review of the Indian Lands Registry and other documents pertaining to the extent of title to the Reserve. The Land Description is not a legal interpretation of those documents. As there may be different legal interpretations of the documents, legal assistance may be required to determine the nature of the legal interests. The content of this Land Description is accurate based on the documents reviewed; however, there may be other documents that were not found or uncovered that may affect the extent of the title to the Reserve.

This Land Description Report was prepared by Cade H. Brown, BCLS, CLS, of the Surveyor General Branch, per the Guidelines established under the authority of the Surveyor General of Canada.

## 2. Land Description

#### Speous Indian Reserve No. 8

Land Description of the Extent of Reserve Lands that will be subject to the Land Code of the Lower Nicola First Nation under the First Nations Land Management Act.

#### Reserve Lands within the Province of British Columbia, Canada In Kamloops Division of Yale District, more particularly described as:

All of Speous Indian Reserve No. 8 shown on Plan 73657 recorded in the Canada Lands Surveys Records (CLSR).

Save and except all that portion of land more particularly described as road parcel shown on Plan 104847 CLSR.

Total Lands containing 114 hectares, (279 acres) more or less.

#### The above described Reserve Lands outside the railway belt are subject to:

The rights and reservations contained in provincial Order in Council 1938-1036, registered in the Indian Lands Registry as No 8042, transferring the land from the Province of British Columbia to Canada, as amended by provincial Order in Council 1969-1555, registered in the Indian Lands Registry as No 4111-118.

#### The above described Reserve Lands within the railway belt are subject to:

The terms and conditions set out Federal Order in Council 1930-208, registered in the ILR as No 15203, describing how Indian Reserves within the Railway Belt were to be excluded from the transfer of the Railway Belt to the Province of BC.

- 2. Refer to the pertinent survey plans and instruments for authoritative boundary definition and nature of the interest in the land.
- 3. The extent of Oil and Gas Rights are not dealt with in this description.

- 5. Mines and minerals are managed according to the British Columbia Indian Reserves Mineral Resources Act 1943-44 c.19.




