

hen'te? band members and community members. Welcome to another month of wind, cool temperatures, very little sunshine and a little rain. May long weekend is usually filled with sunshine, comfortable temperatures and garden prep. I think it is fair to say that we were all shortchanged with blah weather this past long weekend. I am hoping our weather gets better as we gradually move toward our summer season so let's all of us cross our fingers and hope for the best. The month of May seemed to fly right by. The good news about May is how quickly our Rocky Pines bridge construction is going. I had the opportunity to sneak down to the bridge site on the east side of Guichon Creek about a week ago to see the developments and I am very impressed and excited how things are looking. From what I understand, we are way ahead of schedule with the bridge construction, and we are hoping to have a celebration and ceremony next week! Stay tuned for an announcement on the opening of our new Rocky Pines bridge!

LNIB hosted a Murdered and Missing Indigenous Women and Girls gathering on May 5th which started at the Shulus Community Hall and ended at the Shulus Arbor. I want to thank LNIB Administration for supporting this event and I want to personally thank Carole Basil for her leadership in making this gathering happen. We had a very powerful turnout of LNIB Staff, and our LNIB Band school participated too.

NVIT was present along with other groups such as Highland Valley Copper, the RCMP and our neighboring Nations. It was very encouraging to see all the support from abroad. We need to educate our communities of the dangers and risks when it comes to Missing and Murdered Indigenous Women and Girls. This is a very concerning matter that cannot go hidden and go unnoticed. We have women and girls going missing daily across Turtle Island. We need to address this issue and be more diligent in protecting our women and girls. We must take a stand and make our communities safer for everyone. It was a good gathering for everyone. I want LNIB to continue supporting causes such as this to demonstrate that there is zero tolerance for hurting our people. Thanks again to Carole Basil and her team for hosting such a powerful event.

Chief and Council continue to hold duly convened Council meetings on the 1st and 3rd Tuesday of every month. Chief and Council also hold orientation sessions when needed in between the bi-weekly Council meetings. These orientation meetings have proven to be very effective for Council. These sessions are a fantastic way to keep Council informed on other matters of LNIB and these sessions also help prepare Council to address future issues that Council may need to decide upon in the future. LNIB did not have a Band community meeting this month due to the loss of a highly respected Elder in our community. Madeline Lanaro passed away Sunday May 26th. Madeline will be sadly missed by her family and friends. I had a very good and respectful relationship with Madeline. She wasn't afraid to tell me the truth about things, especially if it involved our community. Madeline was very passionate about LNIB. I recall Madeline seeking election to the Chief and Council table on a couple of occasions. Although Madeline never got a seat at the Council table, she was very active at the Band level attending Band meetings and community gatherings regularly. Madeline was a strong presence at LNIB, and I will miss her. It was a pleasure knowing you, Madeline. Thank you for the many lessons you taught me.

Enclosed, I want to wish all of you good health and happiness. Enjoy the new month and let us hope for sunshine and blue skies! Be mindful that wood ticks are still lingering around and please be aware of that. Be safe if you are traveling and keep your pets hydrated if the weather starts to heat up. Here are some of the things we have been working on:

**Rocky Pines Bridge Opening Celebration:** The Rocky Pines Bridge Opening Celebration will be held on June 3, 2024.

Riverside Residential Solar Feasibility: Urban Systems presented at Nana's Hitch and Post on Monday, May 15, 2024 on the installation of solar panels on residential homes. There is an opportunity under certain criteria for the installation and the focus will be Elder's houses. There is an energy audit that is required before installation can be considered and this is done inside and outside the home. More details to follow as this project progresses. 


Community Meetings and Workshops: The next Band General meeting is scheduled for June 24, 2024.




#### Chief and Council Attendance Term October 2022-September 2025

Resolutions from Chief and Council April 30, 2024 meeting

#### Resolution #04-30-2024-01 Reads:

The Lower Nicola Indian Band Chief and Council move to adopt the April 30, 2024 Chief and Council meeting agenda.

#### Motion Carried:

#### Resolution #04-30-2024-02 Reads:

The Lower Nicola Indian Band Chief and Council move to adopt the April 2, 2024 Chief and Council meeting minutes as presented.

#### WHEREAS:

- A. The Lower Nicola Indian Band manages its lands, including the right to reside on its lands, pursuant to its inherent right of self-government, as well as pursuant to the Lower Nicola Indian Band Land Code passed pursuant to the Framework Agreement on First Nation Land Management Act (S.C. 2022, c.19, s.121) (the "Land Code");
- B. The persons listed at section 24.1 of the Land Code, including "invitees" of member interest holders, have a default right to reside (a "Residence Right") on Lower Nicola Indian Band lands (the "Lands"):
- C. Notwithstanding the default Residence Rights of such persons, section 24.1 of the Land Code further allows the Chief and Council (the "Council") to alter or revoke such rights by band council resolution:
- D. Section 24.4 of the Land Code provides that any person who resides or remains on the Lands without a Residence Right is guilty of an offence, and may be evicted, removed or made subject to other consequences;
- E. On April 2, 2024, the Council enacted the Lower Nicola Indian Band Trespass Law to set out additional trespass offences on the Lands and to set out a procedure for the Council to remove a specific Residence Right by way of a Prohibition Order made by band council resolution;
- F. Under section 7.1 of the Lower Nicola Indian Band Trespass Law, the Council may, by band council resolution, issue a Prohibition Order to revoke a person's Residence Right, if the person is invited to reside on the Lands under section 24.1 and the Council has reasonable grounds to believe that the person poses a serious threat or may cause serious harm to the Lower Nicola Indian Band community or land;
- G. James Purdie, who is not a member of Lower Nicola Indian Band, has resided initially in a travel trailer on Lot 326, Nicola Mameet Indian Reserve No. 1 of the Lands approximately between January to July 2023, then in motorhome in October 2023, and most recently since at least April 6, 2024, in a motorhome, and possibly earlier;
- H. On September 20, 2022, Council passed a band council resolution which reads: "The Lower Nicola Indian Band Council hereby prohibits RV's to be utilized as dwellings, residences, or cabins on LNIB Lands including CP Lands and Custom Family Lands unless they receive prior written authorization by the Lands Manager" (the "RV Prohibition Order");

- I. James Purdie never sought or received prior written authorization from the Lands Manager to reside on Lot 326, Nicola Mameet Indian Reserve No. 1 in his travel trailer or motorhome;
- J. On July 4, 2023, Council passed a band council resolution stating that Council is of the view that James Purdie does not fall within the scope of persons who have a Residence Right under section 24.1 of the Land Code and hence he is guilty of an offence under section 24.4 of the Land Code and, in the alternative, if James Purdie does have a Residence Right by virtue of his being an "invitee" of a member interest holder, then Council is of the view that it is in the best interest of the Lower Nicola Indian Band to revoke that Residence Right and Council resolved to revoke any residence right that James Purdie may have pursuant to section 24.1 of the Land Code (the "Revocation Resolution");
- K. On July 27, 2023, Lower Nicola Indian Band staff attempted to served James Purdie with notice of the Revocation Resolution however, James Purdie vacated the Lands sometime before July 27, 2023;
- L. Council is still of the view that James Purdie does not have a Residence Right under Land Code or, in the alternative, if James Purdie has a Residence Right by virtue of being invited to reside on or access the Lands under section 24.1, then Council has removed any such right by way of the Revocation Resolution:
- M. Council is of the opinion that James Purdie's past and present behavior and activities on the Lands pose a threat to Lower Nicola Indian Band community and land and is of the view that it is in the best interest of the Lower Nicola Indian Band to issue a Prohibition Order to remove any remaining right James Purdie may have on the Lands, for greater certainty;

#### NOW THEREFORE BE IT RESOLVED THAT:

- 1. James Purdie does not have a Residence Right on Lower Nicola Indian Band land;
- 2. James Purdie's past and present behavior and activities on Lower Nicola Indian Band lands pose a threat to Lower Nicola Indian Band community and land;
- 3. If James Purdie has any Residence Right by virtue of being invited to reside on Lower Nicola Indian Band lands pursuant to section 24.1 of Land Code, that Residence Right is hereby immediately revoked for a period of three years on all Lower Nicola Indian Band Land in accordance with section 7.1 of the Lower Nicola Indian Band Trespass Law (the "Prohibition Order");
- 4. Notice of the Prohibition Order will be provided to James Purdie as soon as practicable, in accordance with the Lower Nicola Indian Band Trespass Law;
- 5. James Purdie and any person who may have invited James Purdie to reside on Lower Nicola Indian Band lands will have a right to seek a review of the Prohibition Order under section 8 of the Lower Nicola Indian Band Trespass Law; and
- 6. If James Purdie continues to reside on any Lower Nicola Indian Band lands in contravention of the RV Prohibition Order, the Revocation Resolution, and the Prohibition Order, James Purdie will commit an offence under section 24.4 of the Land Code and section 9.2 of the Lower Nicola Indian Band Trespass Law and may be prosecuted by Lower Nicola Indian Band.

Whereas Council approved a total budget amount of \$3,070,000.00 via motion #03-05-2024-12 that approved the addition of precast concrete decking.

Whereas three out of the four pier piles did not reach the desired capacity during restrike, All North engineering required an additional forty feet of length on each failed pile at the pier, with an additional cost of ninety-nine thousand five hundred dollars and zero cents (\$99,500.00);

Now Therefore Be It Resolved, the Lower Nicola Indian Band Chief and Council herby approves Change Order No. 2, that approves additional piling on the pier, in the amount of ninety nine thousand five hundred dollars and zero cents (\$99,500.00) and further approves a total budget to an amount, not to exceed three million one hundred and eighty two thousand three hundred dollars and zero cents (\$3,182,300.00) and further authorizes the Chief, Executive Director, and the Director of Finance, to sign all necessary documents including, but not limited to, approving all invoices and progress payments up to the amended contract limit of three million one hundred eighty two thousand three hundred dollars and zero cents (\$3,182,300.00).

Whereas the inherent rights of the Nłe?kepmx People (First Nations) were recognized and affirmed by the United Nations Declaration on the Rights of Indigenous Peoples, 2007;

Whereas in addition to inherent rights, the Indigenous rights of the Nle?kepmx People in the Nle?kepmx Territory were recognized and affirmed by s.35 of the Constitutional Act, 1982;

Whereas Crown activities and decisions respecting and resource use in the Nłe?kepmx Territory impact the Indigenous rights of the Nłe?kepmx People and, in some cases, the Crown and Lower Nicola Indian Band have entered consultation process agreements to further reconciliation of Lower Nicola Indian Band sovereignty and Crown sovereignty; and

Whereas third party activities and decisions respecting tmíxw and resource use in the Nłe?kepmx Territory will impact the Indigenous rights of the Nłe?kepmx People and, in addition to Crown's duty to consult and accommodate, third parties must engage the Lower Nicola Indian Band to avoid, lessen, and mitigate impacts;

**Therefore be it resolved** Chief and Council of the Lower Nicola Indian Band adopted this tmíx<sup>w</sup> and resource engagement policy with respect to third party's activities in the Nle?kepmx Territory as a systematic approach to address impacts to the Nle?kepmx People's Mode-of-life. **Motion Carried**

- 4. Lower Nicola Indian Band commits to complete the project by 30/09/2025, and
- 5. the Lower Nicola Indian Band certifies that all housing units constructed or renovated will be inspected by qualified inspectors who must confirm that all work meets or exceeds the BC Building Code standards and other applicable code standards. Inspections will be performed at all stages of the project pursuant to BC Building Code. The First Nation agrees that all inspections will be kept on file by the First Nation

#### Resolution #05-21-2024-05 Reads:

#### WHEREAS:

- A. The Lower Nicola Indian Band manages its lands, including the right to reside on its lands, pursuant to its inherent right of self-government, as well as pursuant to the Lower Nicola Indian Band Land Code passed pursuant to the Framework Agreement on First Nation Land Management Act (S.C. 2022, c.19, s.121) (the "Land Code");
- B. The persons listed at section 24.1 of the Land Code, including "invitees" of member interest holders, have a default right to reside (a "Residence Right") on Lower Nicola Indian Band lands (the "Lands");
- C. Notwithstanding the default Residence Rights of such persons, section 24.1 of the Land Code further allows the Chief and Council (the "Council") to alter or revoke such rights by band council resolution;
- D. Section 24.4 of the Land Code provides that any person who resides or remains on the Lands without a Residence Right is guilty of an offence, and may be evicted, removed or made subject to other consequences;
- E. On April 2, 2024, the Council enacted the Lower Nicola Indian Band Trespass Law (the "Trespass Law") to set out additional trespass offences on the Lands and to set out a procedure for the Council to remove a specific Residence Right by way of a Prohibition Order made by band council resolution;
- F. Under section 7.1 of the Trespass Law, the Council may, by band council resolution, issue a Prohibition Order to revoke a person's Residence Right, if the person is invited to reside on the Lands under section 24.1 and the Council has reasonable grounds to believe that the person poses a serious threat or may cause serious harm to the Lower Nicola Indian Band community or land;
- G. James Purdie, who is not a member of Lower Nicola Indian Band, has resided initially in a travel

trailer on Lot 326, Nicola Mameet Indian Reserve No. 1 of the Lands approximately between January to July 2023, then in motorhome during October 2023, and most recently since at least April 6, 2024, in a motorhome, and possibly earlier;

- H. On September 20, 2022, Council passed a band council resolution which reads: "The Lower Nicola Indian Band Council hereby prohibits RV's to be utilized as dwellings, residences, or cabins on LNIB Lands including CP Lands and Custom Family Lands unless they receive prior written authorization by the Lands Manager" (the "RV Prohibition Order");
- I. James Purdie never sought or received prior written authorization from the Lands Manager to reside on Lot 326, Nicola Mameet Indian Reserve No. 1 in his travel trailer or motorhome;
- J. On July 4, 2023, Council passed a band council resolution stating that Council is of the view that James Purdie does not fall within the scope of persons who have a Residence Right under section 24.1 of the Land Code and hence he is guilty of an offence under section 24.4 of the Land Code and, in the alternative, if James Purdie does have a Residence Right by virtue of his being an "invitee" of a member interest holder, then Council is of the view that it is in the best interest of the Lower Nicola Indian Band to revoke that Residence Right and Council resolved to revoke any residence right that James Purdie may have pursuant to section 24.1 of the Land Code (the "Revocation Resolution");
- K. On July 27, 2023, Lower Nicola Indian Band staff attempted to served James Purdie with notice of the Revocation Resolution however, James Purdie vacated the Lands sometime before July 27, 2023;
- L. Council is still of the view that James Purdie does not have a Residence Right under Land Code or, in the alternative, if James Purdie has a Residence Right by virtue of being invited to reside on or access the Lands under section 24.1, then Council has removed any such right by way of the Revocation Resolution;
- M. Council is of the opinion that James Purdie's past and present behavior and activities on the Lands pose a threat to the Lower Nicola Indian Band community and land and is of the view that it is in the best interest of the Lower Nicola Indian Band to issue a Prohibition Order to remove any remaining right James Purdie may have on the Lands, for greater certainty;
- N. On April 30, 2024, the Council issued the Prohibition Order with Resolution #04-30-2024-04;
- O. James Purdie was delivered notice of the Prohibition Order for residence on LNIB Land on May 2, 2024, both in-person and by email;
- P. The deadline for James Purdie to apply for a review of the Prohibition Order pursuant to section 8.1 of the Trespass Law expired on May 14th, 2024, and no application was received; and
- Q. The Council wishes to make a final determination regarding the Prohibition Order pursuant to section 8.3 of the Trespass Law, despite not receiving an application for the review of the Prohibition Order or written submission from James Purdie.

#### NOW THEREFORE BE IT RESOLVED THAT:

The Chief and Council has reconsidered the Prohibition Order at this duly convened meeting and now affirms the Prohibition Order and confirms that:

- James Purdie's past and present behavior and activities on Lower Nicola Indian Band lands pose a threat to Lower Nicola Indian Band community and land;
- James Purdie is guilty of an offence under section 24.4 of the Land Code and section 9.2 of the Trespass Law;
- 3. the Lower Nicola Indian Band will take steps to prosecute such offence; and
- 4. notice of the Prohibition Order will be provided to James Purdie as soon as practicable, in accordance with the Trespass Law.

Animal remains attract predators, leaving remains from a hunting trip too close to the community habituates the predators to keep returning for more food. Predators such as coyotes, bears and wolves will keep returning where there is food available to them. Attracting additional predators into the community will create an unsafe environment for children, pets, and all members of the community. Please relocate hunting remains or animal innards outside of the community by leaving them far away from residences or known industry. An alternative to Mamit Lake Branch Road could be up highway 97C, past the industrial park.

#### PROJECT UPDATE: SECURITY CAMERAS AND GATES

The lands department is responsible for the management and protection of all LNIB reserve lands. To prevent unlawful activity including dumping of hazardous materials and waste, as well as improper use of LNIB, four gates were installed across Nicola Mameet IR1 in September of 2021.

#### **SOLID WASTE MANAGEMENT**

After hours of hard work was done to clean up various environmentally contaminated areas on LNIB land, multiple gates were put in place to protect reserve lands.

#### **CAMERAS**

Security cameras were recently installed near important areas on reserve. Cameras are intended for security purposes only and will not interfere with the privacy of neighboring homes, businesses, and communities. The use of trail cameras is the best strategy for sites where it would not be appropriate to restrict access by installing gates.

## SURVEY CAPACITY DEVELOPMENT PROGRAM

#### Background and Goals:

Indigenous communities are reasserting their inherent right to govern their lands and resources under the Framework Agreement on First Nation Land Management, as communities strive for effective land management, they often seek to enhance their knowledge and skills in various land management activities. A robust land survey system is crucial for this purpose, prompting communities to deepen their understanding of survey-related tools, records, and activities as they implement their land governance systems.

In alignment with the Surveyor General Branch's commitment to reconciliation, the Survey Capacity Development Program has been established with three primary goals:

- 1. Foster Collaboration and Relationship Building:
  - Facilitate knowledge-sharing sessions, including discussions on traditional land use and occupation, and the potential impacts of surveys on these practices.
  - Raise awareness of the role of Canada Lands Surveyors, educational requirements, and career opportunities.
  - Explore land surveying fundamentals, techniques, and methodologies, emphasizing health and safety considerations.
  - Identify collaborative opportunities within community departments impacted by land survey activities.
  - o Examine the survey process, roles, responsibilities, and involved parties.
- 2. Provide Tailored Training Opportunities:
  - o Offer flexibility to communities in selecting training topics from a catalogue of courses.
  - $_{\circ}\;$  Provide in-community training options with customizable timelines.
  - $_{\circ}$  Allow communities to select program participants based on their specific needs.
- 3. Increase Understanding of the Canada Lands Surveys System:
  - o Enhance skills in researching and interpreting land records and survey plans.
  - o Explore the interrelation between the survey system and registry systems.
  - Identify survey plans and land descriptions suitable for registration in the land registry to support transactions.

Through these goals the Survey Development Program aims to support the Lower Nicola Indian Band in its journey towards effective land management, while fostering collaboration, enhancing skills, and increasing knowledge of survey-related processes and systems.

## **Announcement**



#### Septic System Maintenance

Your septic system is a living ecosystem, and you need to do your part to ensure it is healthy and working as it should.

Never put anything down the drain or toilet that will not biodegrade, including but not limited to, wipes (Lysol, baby, etc.), clothes, bottles, feminism products, paper towel, plastic, etc.

Don't use chemicals like bleach as it kills the good bacteria that breakdown the solid waste.

Space out your water consumption so the tank and drain field are not overwhelmed. By this we mean don't do excessive loads of laundry in a day, have extended showers, leave your tap running unnecessarily, etc.

The drain field (or leach field) is the area on your property where wastewater from your septic system is dispersed into the soil. To avoid damaging the drain field and overall functioning of the septic system; - Never park a vehicle, build a structure, have large livestock animals, have fires, or plant trees or a garden over your septic system's drain field - You should also prevent excess water from flowing over your drain field by making sure your downspouts are pointing away from it because a saturated field cannot drain and process wastewater.

These are some of the simple steps that can save time and money and extend the life of your septic system.

#### VEHICLE REMOVAL

We are excited to be partnered with Kamloops Auto Recycling and Mario's Towing for scrap vehicle removal in all our LNIB communities. Keeping our communities clean of old vehicles assists with potential environmental concerns that could arise from batteries, tires, old paint decaying and releasing hazardous substances into the environment. Things like coolant, old oil and other liquids can leak over time, seep into the ground, and contaminate the ground water. We would love to get these old vehicles cleaned up to keep our community healthy for generations to come!

If you have single vehicles, you would like to be picked up you can call Mario's Towing 250-378-9241.





We currently have three vacant units. We are just wrapping up some much-needed renovations, decisions are being made about the next steps for one of these units for when this work is complete. We have been working on some much-needed updates and some structural changes to the other two permanent rentals. We appreciate your patience and understanding as we get this unit ready for the next family that will call it home.



Please understand you're responsible for your animals. You're responsible for any offsprings, any damage to a person, other animals or property that they may have caused. Also keep in mind that pets are to be kept within the confinements of your rental property with the exception of the multi-plex buildings including the 4 plex and new apartment buildings, which are not permitted to have any animals in the units.

As a reminder your pets should be up to date with their vaccinations, should be spayed or neutered. LINB Infrastructure can assist with the cost, up to \$150, only one procedure per year per status number. Make an appointment, pay upfront then submit your receipt and fill out 'Reimbursement Request form'; for more information, please contact Infrastructure Department.

We want to provide a safe environment for our members as well as their animals.



Each creation from Sóxwm is meticulously designed and crafted with care and respect, thoughtfully curated to reflect the essence of the land's natural resources.

From December 2023 to the present day in June 2024, SÓXwM Wood Creations has gained some significant traction in the local craft space and beyond. Lisa, a proud and innovative entrepreneur has been able to leverage her experience, her partner and her Nlaka'pamux heritage to create this wonderful brand and experience.

After the Bear's Den in December 2023, it was clear Lisa had something good that she wanted to bring to the wider marketplace. Lisa figured she would need some financing to fund some new equipment and costs associated with attending markets all over the Thompson Okanagan and through the Lower Mainland and beyond. At the end of the day, All Nations Trust Company and Community Futures of the Central Interior First Nations were approached regarding a grant/loan combination deal through the Indigenous Women's Entrepreneur Program. After shopping around for the potential deal to both entities, Lisa decided to work with Stephanie and her team at Community Futures.

The deal consisted of a grant and loan combination. There were two grants at play, the "Equity Matching Grant" from New Relationship Trust that was able to match the \$5,000 that Lisa has earned through sales to bring her initial equity in the business up to \$10,000. The other grant was the Indigenous Women's Entrepreneur Program. This program includes a loan and non-repayable portion (grant). To access the grant, you need to get a business loan that includes a grant attached to the loan. It is applied immediately and lowers the principal loan amount. This deal helped Lisa and her project provide flexible terms, grant funding, and allow her business to thrive and attend more markets/events, speed up her production speed and diversify her product offering.

#### Lisa's words about working with Economic Development

"I have been working with Adam Ova from the Economic Development Department at LNIB for seven months. Its been a very rewarding experience, it is really intimidating to start a business so having that additional mentorship and someone to hold me accountable to fulfilling all my legal business requirements was vital. In addition to the startup, Adam gave a lot of great advice and he himself is a business owner, he helped me work though a lot of questions I had and provided links and resources to consider in this process. He also helped me establish a business plan which is a minimal requirement when applying for grants. After finalizing the business plan, we went through a series of reviews and applications together and I was able to access a large grant to support my startup costs.

It is not easy, so mentorship is important. The LNIB Economic Development Department are as much a part of my success as I am, and I am glad they provided me with support. Leesa Mike gave me a lot of positive encouragement and a little went a long way. It's hard to find the courage to start a business, but when your community believes in you, you feel a commitment to work through it.



While cooking for ourselves and our family can become so routine it's almost second nature, we must keep in mind there are still fire risks each and every time we use our stoves and/or ovens. Cooking related fires are the leading cause of home fires and/or injuries. These fires are preventable; stay focused, stay alert and remember these safety tips:

The kitchen is often the heart of the home, yet sadly cooking-related fires are a leading cause of home fires and injuries. These fires can be devastating and are preventable!

#### **BEFORE YOU COOK**

Keep it clear and clean. Kitchen fire safety starts with a clean kitchen. Regularly wipe cooking surfaces to prevent food and grease build-up. Keep things that burn, such as paper towels, potholders, dish towels, and plastics away from the stove and other hot cooking surfaces.

Maintain appliances. Keep cooking appliances in good working order. Check electrical cords and plugs and discard any that are damaged. Avoid overloading electrical outlets with too many appliances and be sure to unplug small appliances

Have an early warning. Working smoke alarms save lives by providing an early warning of smoke and fire. Install working smoke alarms at least 10 feet from cooking appliances to minimize false alarms or use a smoke alarm designed to be near kitchens.

Have a fire extinguisher. Keep a fire extinguisher close by in case of a small fire. Know how and when

#### WHILE YOU COOK

Stay present and alert. Cooking requires your full attention. Check cooking food regularly and always stay in the kitchen when frying, boiling, grilling, or broiling food. If you must leave, turn off all cooking appliances.

Protect children and pets. Keep children and pets at least 3 feet from cooking areas. This safe zone will protect them from potential burn injuries caused by hot foods and liquids.

Prevent burns. Cooking-related scalds and burns can be severe and painful. Protect yourself and your loved ones by turning pot handles away from the edge of the stove where they could be knocked over, keeping hot food and beverages away from counter edges, and removing lids from hot substances with care. Use oven mitts or potholders when touching anything that could be hot.

#### **AFTER YOU COOK**

Clean Up. Wipe up spills and splatters on the stove-top, in the oven, and microwave. Put things that can burn away from heat sources and always let grease cool before discarding it.

Look before you leave. When you finish cooking, turn off the oven, stove burners, and small appliances. Do a final check that everything is off before leaving home or going to bed.

#### **EXTINGUISH SMALL FIRES**

If you have any doubt about extinguishing the fire. get everyone out of the home, and call 9-1-1 or your local emergency number from outside.

Fire needs heat and oxygen to burn. To put out a small grease fire slide a lid over the pan to smother the flames, then turn off the element. Do not move the pot or remove the lid until it has cooled. For oven and microwave fires, close the appliance door and turn off the heat.

NEVER put water on a grease fire!

Fire extinguishers are only for small fires. Use an extinguisher if you know how and have a clear exit behind you in case the fire gets out of control. If in doubt, leave the home immediately and call 9-1-1 or your local emergency number.







#### SPRINGING INTO SUMMER!

Summer! It is always amazing to me how this season of the year seems to improve peoples' outlook on their lives. It is almost like we "give ourselves permission" to relax and cast off the stress of the rest of the year? (Perhaps that is the key to managing well in the other 3 seasons?). It can be a time full of excitement and happiness but, like every other season, it still depends on how we spend our time. In fact, summer is a great time to invest in lifestyle habits and support your mental health. There is science that points to summer being a time of better mental health.

How the summer affects mental health

One of the main ways the summer can help with mental health is through the sunshine. Because of the warmer weather, many of us spend more time outdoors in the summer, plus the sun is out for longer than in other seasons.

The increased sun exposure boosts our vitamin D levels, and can even improve mood, leading to better mental health. Spending time in the sun also helps your body produce more melatonin (sleep hormone) at night, allowing you to sleep better and overall feel better. While there are some stressors unique to summer, such as feeling overwhelmed by the number of activities and getting less sleep, it is a good time for most people's mental health. Therefore, it is a good time to set habits and prepare for the coming months that are colder and less energizing.

#### Healthy To-Do's:

Watch Your Time: activities increase with good weather, but you don't have to say yes to every opportunity. In fact, you don't want to, or you will burn out. Think about which activities and plans seem the best to you and take breaks when you need them.

- Keep your Sleep: Longer daylight hours are awesome but don't burn the candle at both ends. One possible way to do this is by sleeping in the sun don't stay up for too long since it is dark outside.
- Get out and get Active: being in action can have great benefits on your mental health.
   Warmer weather means more play time! Find 1 or 2 ways to get yourself moving and enjoy
- Have fun! Never sacrifice all your "fun" in order to "improve" your mental health. It will
  only have the opposite effect. Of course, notice what you need and be disciplined to grow
  but you need to enjoy life too. Find a balance between responsibility and fun!
