AND WHEREAS Chief Jordna Hill and Shamattawa First Nation have commenced a class action in the Federal Court against Canada bearing court file number T-1937-22 (the "Action") to seek immediate solutions to address long-term drinking water advisories on reserve and compensation for the harms suffered by individuals and First Nations;

AND WHEREAS the Federal Court certified the Action as a class proceeding;

AND WHEREAS Chief Jordna Hill and Shamattawa First Nation are jointly represented by the law firms McCarthy Tétrault LLP and Olthuis Kleer Townshend LLP ("Class Counsel");

AND WHEREAS the class includes the members of First Nations that have been impacted by long-term drinking water advisories since June 20, 2020, as well as those impacted First Nations that elect to opt in;

AND WHEREAS the members of impacted First Nations will automatically be included in the class unless they opt out of the Action;

AND WHEREAS impacted First Nations must choose to opt into or join the Action to assert collective claims;

AND WHEREAS the Band Council may opt eligible First Nations into the Action by passing a resolution;

AND WHEREAS the Band Council may also elect to retain Class Counsel in respect of any individual issues arising in the Action;

#### THEREFORE BE IT RESOLVED THAT:

 Chief and Council of Lower Nicola Indian Band hereby retain Class Counsel and opt into the Action, such that Lower Nicola Indian Band shall be a member of the class represented in the Action.
 Chief and Council of Lower Nicola Indian Band hereby direct Kwuwwpi? (Chief) Stuart Jackson,

on behalf of Lower Nicola Indian Band to enter into a retainer agreement with Class Counsel on such terms as Lower Nicola Indian Band considers appropriate, and such retainer agreement shall be deemed to have been approved by Council.

Whereas the LNIBDC carries out its operations through businesses that it owns in whole or in part and through other business arrangements (the LNIBDC's Operations).

Whereas the LNIB has not received any revenue or profit from the LNIBDC's Operations for over 3 years, as a result the LNIBDC has failed to provide a benefit to the LNIB or its members.

Whereas the LNIBDC has failed to meet the expectations set out in the Letter of Owners Expectations dated July 25, 2017 (the "Expectations").

Please refrain from leaving hunting remains, animals' entrails or trimmings up Mamit Lake Branch Road or anywhere near the community / residential areas.

Animal remains attract predators, leaving remains from a hunting trip too close to the community habituates the predators to keep returning for more food. Predators such as coyotes, bears and wolves will keep returning where there is food available to them. 

### **Myrtle Spurge**

Euphorbia myrsinites





"Myrtle spurge is toxic to humans, livestock and wildlife when consumed, or when its sap (latex) contacts skin. The sap causes nausea, vomiting and diarrhea when eaten. It can cause blindness if it gets in people's eyes and skin contact causes redness, swelling and blisters. This plant is recognized as invasive and toxic in BC."

-Invasive Species Council of BC

#### **Description:**

Commonly known as Blue Spurge, Donkey Tail or Wolf's Milk, this perennial escapes from ornamental gardens, spreading aggressively in dry disturbed soils. Myrtle Spurge grows roughly 10-15 cm in height and has distinguished clusters of yellow/green flowers found at the end of each stock. These invasives spread primarily by seed but broken off plant / root fragments can also form new plants; seeds can remain viable in soil for up to seven years. When broken, Myrtle Spurge emits a milky latex sap that irritates the skin of humans and animals alike, causing blisters and swelling. All parts of this weed are toxic and the root systems disperse an allelopathic compound into the soil that inhibits the growth of surrounding plants. This quality combined with its aggressive nature to spread rapidly, enables this invasive to out compete native vegetation and can easily spread to a monoculture infestation.



#### **Origin:**

This invasive originated in Europe.

#### **Control Options:**

#### Prevention

- Reseed all areas where ground disturbance has occurred and minimize ground disturbance near invasive weeds.
- Remove seeds and plant fragments from gear, equipment, or vehicles before leaving a site. Clear Livestock of seed or plant fragments before changing pastures.
- <u>Do not compost</u> this plant, as root and stem fragments can continue to grow and resprout after being removed.
- Avoid tilling or digging near this weed as fragmented pieces can sprout into a new plant.



#### **Cultural Control**

- Burning may be an effective tool to reduce the surface growth of the weed but this method would either need to be repeated regularly or used in combination with other control methods to prevent vegetative regrowth.
- Reseed any disturbed / bare soil with native plant species.



#### **Mechanical Control**

- Hand-pulling small infestations is effective, ensure the entire root system is removed and bag the removed plants before disposal to prevent root systems detaching and spreading. Wear Gloves and long sleeves to avoid contact with the sap!
- Mowing patches of Myrtle Spurge repeatedly will prevent it from setting seed, but this method may also result in vegetative reproduction, plus causing the plant to spread via the plants fragments left behind establishing roots.



#### **Chemical Control**

- "Herbicide recommendations and use must first consider site characteristics and be prescribed based on site goals and objectives. Herbicide labels and other sources or information must be reviewed before selecting and applying herbicides » Herbicides can eliminate small patches of leafy spurge with persistent treatments. Larger areas require additional (integrated) control measures, because long term control is extremely difficult to achieve with any single control method. Thus, herbicides are an important component of any integrated pest management (IPM) program focused on leafy spurge control.
- » Proper timing of herbicide applications is essential for good Leafy spurge control.
   Leafy spurge is most susceptible to picloram alone or picloram plus 2,4-D or
   dicamba plus 2,4-D applications when the plant is in the true flowering and seed

production stage from mid-to late June, or in early to mid-September after the stems have developed new fall re-growth.

- » Glyphosate, a non-selective herbicide, provides good leafy spurge control when applied during active growth" – <u>ISCBC</u>
- "Several herbicides with the following active ingredients can control Myrtle spurge: picloram, 2, 4-D, dicamba, and glyphosate. For available products, contact your local agri-supply store. Prior to any herbicide application, read and follow the label instructions" <u>– TNRD</u>
- Chemically treated plants can be left onsite to compost.



\*Disclaimer\* - ANY & ALL herbicide applications must be applied as spot spraying; broadcast spraying may negatively impact other vegetation in the area & harm sensitive ecosystems.

## Herbicide application within 5m of any body of water (seasonal or not) is <u>prohibited</u>.

LNIB requesting that the application of herbicide to treat half an acre or more, is carried out by a person holding a valid BC Pesticide Applicator Certificate. Before selecting and applying herbicides, you must review and follow herbicide labels and application rates; municipal, regional, provincial, and federal laws and regulations; species-specific treatment recommendations, and site-specific goals and objectives.

## PROJECT UPDATE: SECURITY CAMERAS AND GATES

The lands department is responsible for the management and protection of all LNIB reserve lands. To prevent unlawful activity including dumping of hazardous materials and waste, as well as improper use of LNIB, four gates were installed across Nicola Mameet IR1 in September of 2021.

#### SOLID WASTE MANAGEMENT

After hours of hard work was done to clean up various environmentally contaminated areas on LNIB land, multiple gates were put in place to protect reserve lands.

#### CAMERAS

Security cameras were recently installed near important areas on reserve. Cameras are intended for security purposes only and will not interfere with the privacy of neighboring homes, businesses, and communities. The use of trail cameras is the best strategy for sites where it would not be appropriate to restrict access by installing gates.

## SURVEY CAPACITY DEVELOPMENT PROGRAM

Background and Goals:

Indigenous communities are reasserting their inherent right to govern their lands and resources under the Framework Agreement on First Nation Land Management, As communities strive for effective land management, they often seek to enhance their knowledge and skills in various land management activities. A robust land survey system is crucial for this purpose, prompting communities to deepen their understanding of survey-related tools, records, and activities as they implement their land governance systems.

In alignment with the Surveyor General Branch's commitment to reconciliation, the Survey Capacity Development Program has been established with three primary goals:

1. Foster Collaboration and Relationship Building:

- Facilitate knowledge-sharing sessions, including discussions on traditional land use and occupation, and the potential impacts of surveys on these practices.
- Raise awareness of the role of Canada Lands Surveyors, educational requirements, and career opportunities.
- Explore land surveying fundamentals, techniques, and methodologies, emphasizing health and safety considerations.
- Identify collaborative opportunities within community departments impacted by land survey activities.
- o Examine the survey process, roles, responsibilities, and involved parties.

2. Provide Tailored Training Opportunities:

- Offer flexibility to communities in selecting training topics from a catalogue of courses.
- Provide in-community training options with customizable timelines.
- Allow communities to select program participants based on their specific needs.

3. Increase Understanding of the Canada Lands Surveys System:

- o Enhance skills in researching and interpreting land records and survey plans.
- o Explore the interrelation between the survey system and registry systems.
- Identify survey plans and land descriptions suitable for registration in the land registry to support transactions.

Through these goals the Survey Development Program aims to support the Lower Nicola Indian Band in its journey towards effective land management, while fostering collaboration, enhancing skills, and increasing knowledge of survey-related processes and systems.

# Housing Announcement

## Septic System Maintenance

### DO NOT USE KIRKLAND BRAND TOILET PAPER, as it does not break down and clogs the toilet.

Your septic system is a living ecosystem, and you need to do your part to ensure it is healthy and working as it should.

Never put anything down the drain or toilet that will not biodegrade, including but not limited to, wipes (Lysol, baby, etc.), clothes, bottles, feminism products, paper towel, plastic, etc.

#### Don't use chemicals like bleach as it kills the good bacteria that breakdown the solid waste.

Space out your water consumption so the tank and drain field are not overwhelmed. By this we mean don't do excessive loads of laundry in a day, have extended showers, leave your tap running unnecessarily, etc.

The drain field (or leach field) is the area on your property where wastewater from your septic system is dispersed into the soil. To avoid damaging the drain field and overall functioning of the septic system; - Never park a vehicle, build a structure, have large livestock animals, have fires, or plant trees or a garden over your septic system's drain field - You should also prevent excess water from flowing over your drain field by making sure your downspouts are pointing away from it because a saturated field cannot drain and process wastewater.

These are some of the simple steps that can save time and money and extend the life of your septic system.

## Security and Land Guardianship

This month's article from Economic Development will feature an LNIB member owned business that was conceptualized over a conversation between friends.

**Nekusem Security and Land Guardianship**, created, owned and managed by LNIB Member Derek Trosky, his wife Chelsea Trosky, his friend Eagle Casmir (KIB member) and his wife Francyne Prairie Chicken (Piikani Nation, Southern Alberta, born and raised in the Secwepemc nation and grew up on the St'uxwtews First Nation) is a security and land guardianship company that offers security and patrolling services, event security and land guardianship services in the Thompson Okanagan and to neighboring First Nations.

This company was formed when Derek mentioned to the group that they should start a business and the idea of a security and land guardianship business came by pure chance from Eagle. From that point on, the consortium of the two couples decided to put together a business plan and try their luck with obtaining a grant and financing.

After the group put their best foot forward and approached a financial institution, they unfortunately had a discouraging response from this institution who immediately turned down their application and offered no support. This is when Derek suggested that they contact LNIB Economic Development.

Working with LNIB Economic Development

At the end of February 2024, the group reached out to the Economic Development Department seeking help with a business plan and package they could shop around to other institutions with the hopes of securing a grant and loan for their business.

After several meetings with Nekusem and the team, along multiple revisions to the business plan and cashflow forecast, a solid plan was drafted, and they were ready to reengage with potential financiers and obtain financing and grants.

During the second approach, Nekusem contacted Stephanie Fletcher at Community Futures of the Central Interior First Nations. With their ducks in a row they wanted to get some working capital through a loan and a grant through the New Relationship Trust Equity Matching Grant. They were also able to secure a loan to go along with the grant to secure working capital for their runway for takeoff.

#### **Nekusem Today**

As of the writing of this article, Nekusem has completed their first job as a company and has many more on the go. The team has secured an office space and continues to book events, patrol contracts and eventual land guardianship contracts throughout the Thompson Okanagan.

#### Nekusem's words about working with Economic Development

"We reached out to Adam Ova in February looking for some help and insight on building our company and business plan. Adam walked us through everything we needed and went above and beyond to ensure we had a solid business plan in place. He kept us on track and helped us meet our company goals quicker than we had imagined. We continue to reach out to Adam for advice and he continues to help us in any way he can as we grow our business."








## LNIB Development Corporation to take over operation of Shulus Community Gardens
